SCREEN_ is and always will be an Opt-In email subscription. We collect only your name and your email when you sign up to receive our monthly email-based artworks. By signing up, you agree to the collection and use of information in accordance with this policy.

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you sign up to receive SCREEN_ emails and the choices you have associated with that data.

Information Collection And Use

We collect only your name and email.

Types of Data Collected

Personal Data

we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Cookies and Usage Data

Usage Data

We also collect information on how SCREEN_ emails are accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

Tracking & Cookies Data

We use cookies and similar tracking technologies to track user activity and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent.

Use of Data

SCREEN_ uses the collected data for various purposes:

- To notify you about changes to our program
- To allow you to participate in interactive features when you choose to do so
- To provide analysis or valuable information so that we can improve our program
- To monitor the usage of the Service
